

# Peñasco Valley Farmers Market Rules and Guidelines

The following rules and guidelines have been established to ensure a safe and enjoyable experience for both vendors and patrons at the Peñasco Valley Farmers Market (PVFM). By participating in or attending the market, you agree to comply with these rules:

#### Conduct and Behavior:

- a) The use of drugs and alcohol is strictly prohibited on the market premises.
- b) The market is a child-friendly environment. Please refrain from using explicit language or engaging in inappropriate behavior that may offend or disturb others.

## Respect and Consideration:

- a) Treat vendors, patrons, market staff, and volunteers with respect and courtesy.
- b) Maintain a clean and tidy environment by properly disposing of trash in designated bins.
- c) Respect the personal space and property of others, including vendors' booths and products.

#### Pets:

- a) Pets are allowed at the market but must be kept on a leash at all times.
- b) Please clean up after your pet and dispose of waste in designated receptacles.

#### Parking and Traffic:

- a) Follow all parking regulations and instructions provided by market staff.
- b) Observe designated parking areas and respect private property in the vicinity of the market.

#### Market Hours:

a) The market opens promptly at 9AM and closes at 1PM. Please plan your visit accordingly.

## Vendor Scheduling and Reservation:

- a) Vendors are permitted to show up on the day of the market without scheduling ahead of time. However, booth spaces will be allocated on a first-come, first-served basis.
- b) To secure a guaranteed spot at the market, vendors are encouraged to reserve their space ahead of time by contacting the Market Manager. Reservations can be made by calling 505-923-0124 or emailing stanthonyproject575@gmail.com
- c) Vendors who have reserved their spot in advance will have priority in choosing their desired location within the market. However, it is important to note that reserved spaces will only be held until 8:30 AM)on the market day. If a vendor fails to arrive and claim their reserved space by the specified time, it may be allocated to another vendor on a first-come, first-served basis.
- d) All vendors, whether they have reserved their space or not, must sign the Vendor Agreement before setting up their booth. The Vendor Agreement outlines the terms and conditions for participating in the market and ensures compliance with rules and regulations.



e) Limited tables and tents available for vendor use on a first come first serve basis. Vendors borrowing equipment are required to call ahead of time to notify Market staff, and show up no later than 8:15AM for setup.

## COVID-19 Safety:

- a) Follow all current COVID-19 safety guidelines and protocols as recommended by local health authorities.
- b) Practice physical distancing and wear a mask if required or recommended.
- c) Stay home if you are feeling unwell or exhibiting symptoms of illness.

## Market Staff and Volunteer Instructions:

- a) Follow any instructions provided by market staff and volunteers to ensure a smooth and organized operation.
- b) Seek assistance from market staff or volunteers if you have any questions, concerns, complaints, or require information.

### Compliance and Enforcement:

- a) Failure to comply with these Market Rules and Guidelines may result in removal from the market premises and future market participation may be restricted.
- b) Market staff and volunteers are authorized to enforce these rules and guidelines and have the right to take appropriate action to ensure compliance.
